#### **BACKGROUND SUMMARY**

Anil is a seasoned executive with proven success in developing and executing business and operational strategies that consistently improve efficiencies and increase profits. Anil also collaborated with customers in the development of material blends.

Wilkinson/Dispozo Industries Inc.: As Vice President of Operations for this \$180M foodservice packaging manufacturer, Anil led manufacturing, engineering, and supply chain operations. He reduced the safety incident rate by over 33% through enhanced communications, education, and a focus on accountability. Anil improved plastics operations productivity through data collection, analysis, and implementation of process and personnel changes. He improved adherence to the planning schedule from 62% to 87% in two years. Anil implemented the Preventive and Predictive maintenance process that improved equipment and infrastructure performance, reducing downtime by 15%. He negotiated material and supply contracts, generating over \$3M in savings while extending payment terms to improve cash flow. He also negotiated a transportation contract with a 3rd party logistics company to generate an estimated 5% in annual savings (\$400,000). By streamlining manufacturing, purchasing, and planning, Anil reduced draw and finished goods inventory by 20% to improve cash flow, decrease backorders, and improve overall customer service levels. Additionally, he played an instrumental role in Dispozo's due diligence and merger with Wilkinson.

**Solo Cup Company:** As Executive Vice President of Global Operations for this \$2.4B global leader in disposable foodservice products, Anil led operations across 19 domestic and 9 international facilities with P&L responsibility for a \$1.7B budget and a team of over 9,000 employees. He managed the operations integration of 4 different and distinct divisions and 31 manufacturing facilities from a \$1.2B acquisition, restructuring the operations organization, driving \$45M savings in operational efficiencies, and establishing standard processes that achieved synergies and created an organization operating in a unified culture. He also implemented Lean and Six Sigma methodologies, improving quality and generating \$10M in cost savings.
